26 This action came on regularly for trial on April 13, 2009, and continuing until May
27 8, 2009, in Department 40, of the above entitled court, and objections to the statement of
28 intended decision having been heard on August 27, 2009, in Department 308, of the above

1 entitled court, the Honorable Ann I. Jones, Judge, presiding, sitting without a jury. Plaintiffs
2 "BEAUX CARSON, individually and dba CARSON ENTERTAINMENT GROUP; and,
3 CARSON SIGNATURE FILMS, INC.; JACK PRICE; and KAY L. NELSON, aka KAY
4 CARSON, individually and dba THE DANCE COMPANY BY KAY L. NELSON,"
5 appearing by Scott D. Myer and the Myer Law Firm, counsel; Defendant "DAMA C.
6 CHASLE, aka DAMA CLAIRE CHASLE, aka DAMA CHASLE, aka DAMA CHAZEL,
7 aka DAMA DICKERSON, aka DAMA STRIZAK, individually and dba SOARING
8 EAGLES PRODUCTIONS," appearing by Tom A. Nunziato, and Illece Buckley-Weber, and
9 Nunziato Buckley Weber LLP, counsel. Oral and documentary evidence was presented by
10 all parties. The cause was argued and submitted for decision. A Statement of Decision has
11 been made and filed, and this Judgment is made in accordance with that Statement of
12 Decision.

13 NOW, THEREFORE, IT IS ADJUDGED, ORDERED, AND DECREED that:

14 1. Plaintiffs "BEAUX CARSON, individually and dba CARSON
15 ENTERTAINMENT GROUP; and, CARSON SIGNATURE FILMS, INC.," are awarded
16 from Defendant "DAMA C. CHASLE, aka DAMA CLAIRE CHASLE, aka DAMA
17 CHASLE, aka DAMA CHAZEL, aka DAMA DICKERSON, aka DAMA STRIZAK,
18 individually and dba SOARING EAGLES PRODUCTIONS," the sum of \$926,000.00, as
19 actual damages sustained by said Plaintiffs; less the award to Cross-Complainant "DAMA
20 C. CHASLE," from Cross-Defendant "BEAUX CARSON," of the sum of \$5,000.00, as
21 statutory damages; for a net judgment for the Plaintiffs "BEAUX CARSON, individually and
22 dba CARSON ENTERTAINMENT GROUP; and, CARSON SIGNATURE FILMS, INC.,"
23 who shall recover from Defendant "DAMA C. CHASLE, aka DAMA CLAIRE CHASLE,
24 aka DAMA CHASLE, aka DAMA CHAZEL, aka DAMA DICKERSON, aka DAMA
25 STRIZAK, individually and dba SOARING EAGLES PRODUCTIONS," the sum of
26 \$921,000.00, as actual damages sustained by said Plaintiffs, and the sum of
27 \$ 11,942.11 , for fees and costs herein incurred, plus post-judgment interest as
28 allowed by law.

1 2. Plaintiff "JACK PRICE" shall recover from Defendant "DAMA C. CHASLE,
2 aka DAMA CLAIRE CHASLE, aka DAMA CHASLE, aka DAMA CHAZEL, aka DAMA
3 DICKERSON, aka DAMA STRIZAK, individually and dba SOARING EAGLES
4 PRODUCTIONS," the sum of \$700,000.00, as actual damages sustained by said Plaintiff,
5 and the sum of \$ 484,50, for fees and costs herein incurred, plus post-judgment
6 interest as allowed by law.


7 3. Plaintiff "KAY L. NELSON, aka KAY CARSON, individually and dba THE
8 DANCE COMPANY BY KAY L. NELSON," shall recover from Defendant "DAMA C.
9 CHASLE, aka DAMA CLAIRE CHASLE, aka DAMA CHASLE, aka DAMA CHAZEL,
10 aka DAMA DICKERSON, aka DAMA STRIZAK, individually and dba SOARING
11 EAGLES PRODUCTIONS," the sum of \$1,182,800.00, as actual damages sustained by said
12 Plaintiff, and the sum of \$ 365.00, for fees and costs herein incurred, plus waived
13 costs, plus post-judgment interest as allowed by law. Costs in the amount of
14 \$ 0, (total of amount of all fees waived) and any costs after judgment are
15 payable to the Clerk under Section 68511.3 (forma pauperis) of the Government Code.

16 4. Further, the Court finds that Defendant "DAMA C. CHASLE, aka DAMA
17 CLAIRE CHASLE, aka DAMA CHASLE, aka DAMA CHAZEL, aka DAMA
18 DICKERSON, aka DAMA STRIZAK, individually and dba SOARING EAGLES
19 PRODUCTIONS," acted with actual malice against all Plaintiffs.

20 IT IS ADJUDGED, ORDERED, AND DECREED.
